

SPONSORSHIP AGREEMENT

By and Between

Liesno Buno S.L. and EASP Escuela Andaluza de Salud Publica

This Sponsorship Agreement (the “**Agreement**”) effective as of October 6, 2025 (the “**Effective Date**”) between Liesno Buno S.L. having its principal place of business at Avda. De Aragon 330, Las Mercedes North Module, Floor 4, Building 6, 28022 Madrid, Spain (the “**Sponsor**”) and EASP Escuela Andaluza de Salud Publica (“**Sponsored Entity**”), having its principal place of business at Cta. del Observatorio, 4, Granada, Andalucía, 18011, España is entered into in connection with the services or sponsorship opportunities (“**Services**”) more fully described in Exhibit A, attached hereto and made a part of this Agreement.

1. **Term.** This Agreement shall commence on the Effective Date and end on October 20, 2025.
2. **Sponsor Rights:** All rights and benefits that will be provided to Sponsor, including any exclusivity, will be fully outlined in Exhibit A.
3. **Sponsorship Fees.** Sponsor shall pay to Sponsored Entity the following:
 - a. **Fee:** 2,000.00 EUR excl. VAT. Any such VAT will be paid in addition to the agreed values upon receipt of a valid VAT invoice.
 - b. **Refund:** In the event the Services do not occur for any reason in or out of the control of Sponsored Entity, Sponsor shall receive a pro-rata refund of its Sponsorship Fees.
4. **Use of Trademarks:** Each party grants to the other a limited, non-exclusive, royalty-free, non-transferable right and license to use certain names, marks and logos (the “**Marks**”) of the other (i) only in connection with the purposes of this Agreement, and (ii) only upon prior approval from the trademark owner. Except as expressly provided herein, no property, license, permission or interest of any kind in or to the use of any logo, trademark, trade name, color combination, insignia or device owned or used by a party is intended to be given or transferred to or acquired by another party by the execution, performance or nonperformance of the Agreement or any part thereof.
5. **Independent Contractor.** It is expressly agreed that the parties will be independent contractors and that the relationship between the parties will not constitute a partnership, joint venture or agency of any kind. Sponsored Entity is not authorized to make any representation, contract, or commitment whatsoever on behalf of Sponsor.
6. **Authority/Necessary Rights:** Each party represents and warrants that it possesses all rights and interests necessary to enter into this Agreement, and to perform its obligations under this Agreement.
7. **Assignability:** Except as expressly provided hereunder, neither this Agreement nor any rights or obligations hereunder may be assigned or otherwise transferred, including by statutory merger, sale of assets or stock, or otherwise by Sponsored Entity without the prior written consent of Sponsor.
8. **Termination:** Either party may terminate this Agreement at any time upon thirty (30) days’ prior written notice to the other party.
9. **Confidentiality:** Each party hereby agrees that the terms hereof are confidential and shall not be revealed or disclosed to any third party, except each party’s respective officers, directors, employees (on a need to know basis), contractors, affiliates, representatives and agents who agree to be bound by the confidentiality provisions hereof. The foregoing notwithstanding, each party may disclose such terms as may be required by law.
10. **Injunctive Relief:** The parties agree that any breach of the provisions hereof relating to trademarks or confidentiality may cause irreparable injury and that actual damages may be difficult to ascertain, and in any event, may be inadequate. Accordingly (and without limiting the availability of legal or equitable, including injunctive, remedies under any other provision of this Agreement or otherwise), the parties agree that in the event of any such breach, the non-breaching party shall be entitled to seek injunctive relief in addition to such other legal and equitable remedies that may be available.

11. **Insurance:**

- a. Throughout the Term of this Agreement, Sponsored Entity shall arrange and maintain, with financially sound and reputable insurers, appropriate insurance for the Services.
- b. Sponsored Entity shall, on written request, provide Sponsor with evidence of such insurance coverage.

12. **Governing Law:** This Agreement shall be governed by the laws of Spain as those laws are applied to contracts entered into and performed in Spain. Any claim or controversy arising out of or related to this Agreement, or any breach hereof shall be submitted to a court of applicable jurisdiction in Spain, and each party hereby consents to the exclusive jurisdiction and venue of such court.

13. **Notices.** All notices and other communications required to be provided hereunder will be in writing and will be deemed to be sufficiently given if sent by either electronic mail, certified mail return receipt requested, pre-paid nationally recognized delivery service, or by hand delivery addressed as follows:





Se estima que el número de personas asistentes será de 300 para cada ciudad.


